Dealer orders are accepted subject to the following conditions which supersede any conflicting conditions contained in the Dealer's purchase order.

Prices

All prices are subject to change without notice. Possession of a catalog does not authorize discount pricing. M&H Electric Fabricators Inc. reserves the right to adjust a Dealer discount price level or revoke dealer status at any time. Shipments will be billed at the prices in effect at the time the original order was placed. Custom quoted items will be billed at quote price before the quote expiration date. Quote prices are subject to change after the quote expiration date.

Backorders

When placing their first order, Dealers will be asked to choose their default shipping terms for future orders:

- 1. Ship Complete (Hold shipment and ship once all items become available)
- 2. Ship Partial (Ship each item as it becomes available)
- 3. Ship partial, Ship Back Order Complete (Ship all items in stock now, hold all back ordered items and ship once they all become available).

Dealer default shipping terms may be changed on a per order basis at the time of the order. Be aware that some shipping terms may incur additional shipping charges.

Delays

Delivery dates indicated on quotations and/or Order Verifications of orders are accurately estimated, but are not quaranteed.

Shipping Terms

All products will be shipped via UPS, Fed Ex or USPS, F.O.B. Santa Fe Springs, CA 90670 unless other arrangements are made at the time of the order. 3rd Party Billing is available.

Claims

Claims for Order errors, order deficiencies (missing items) or shipping damage must be made in writing or by phone within seven (7) days of receipt of goods. The absence of such notice within the specified time will constitute an acceptance of the shipment as delivered. Damaged or missing shipment claims require carrier approval. Approval times vary by carrier and lead time.

Returns

Normal Dealer returns for items ordered in error will be accepted for credit only. NO REFUNDS WILL BE ISSUED. Returned merchandise must be in unused condition and in the original sealed packaging. Credit will be issued only for the amount actually paid for the product without consideration for freight. No returns will be accepted without prior authorization. Refusals

Dealers refusing a C.O.D. shipment will be billed a 20% restocking fee plus shipping to and from the destination. Your account will be put on hold until all charges are paid.

Cancellation of special order, custom order or built to order items.

In case of cancellation of a special order, custom order or Build to order items, the buyer will be liable for completed production, for the material in process of fabrication for the order, for materials purchased specifically for the order or contract and for any related unamortized special costs.

Method of Payment

Payment methods will be identified at the time of the Dealer application process. Most Dealers will choose to use a credit card. We accept Visa, Master Card, American Express and Discover cards. M & H employs the latest technology for safe and secure credit card transactions. Net terms can be negotiated and based on credit approval after a term of 1 year of business with M & H. All terms are strictly enforced unless otherwise negotiated in advance.

Indemnity

With respect to all goods manufactured either in whole or part to buyer's specifications, buyer will protect and indemnify the seller against all claims for damages or profits arising from infringement of patents, designs, copyrights or trademarks not known at the time of the order.

Errors

Warranty

Seller's standard warranty policy applies to all products manufactured by seller except where noted in these Terms & Conditions.

One Year Limited Warranty

M & H Electric Fabricators Inc. warrants products to be free from defects in materials and workmanship for a period of one (1) year from the date of the original purchase by the end user, except where noted on individual items which may have an extended warranty period. M & H Electric Fabricators Inc. will, at their discretion, repair or replace the product in the event of a manufacturing defect as follows: Parts: Repair or replacement in exchange for defective parts returned to our facility for one (1) year after the date of original purchase. Labor: Repair or replacement of defective product returned to our facility for one (1) year after the date of original purchase. Liability of M & H Electric Fabricators Inc. is limited to the repair or replacement of the defective product only. This warranty does not cover additional costs arising from the defect of the product such as inconvenience, labor, installation, damage, customer modification, postage, freight or delivery fees for sending the product to and from our facility. All returned products must include a Return Material Authorization (RMA). Please contact our Customer Service department for an RMA and instructions for returning the product to our facility. All returned products are subject to damage inspection.

Price Column Identification & Initial Order Requirements

Our pricing policy allows Dealers to purchase our products at a discount level based on their initial stocking order and/or yearly sales volume. We have established three discount levels.

Trade Pricing

This price level is extended as a courtesy to auto parts stores, body shops, restoration shops and low volume buyers. An initial request must be made on company letterhead.

Jobber Pricing

An initial stocking order of \$ 800.00 is required in order to receive Jobber pricing. There is no minimum re-order amount. A yearly minimum sales volume of \$ 2,500.00 must be maintained in order to maintain Jobber account status.

Wholesale Pricing

An initial stocking order of \$1,500.00 is required in order to receive Wholesale pricing. There is no minimum re-order amount. A yearly minimum sales volume of \$5,000.00 must be maintained in order to maintain Wholesale account status.
